## CONSTITUTION OF SCHOOL MANAGEMENT COMMITTEE

### Abstract

As per the Right of Children to Free and Compulsory Education Act 2009 of Government of India, it is mandated to form School Management Committees in all schools with certain laid down roles and responsibilities in the Act. The Government has notified RTE Rules 2011 and issued orders in Government Order 3rd read above which lay down the roles and responsibilities.

### Composition of School Management Committee


In accordance to the adherence of RTE Act 2022, the Imperial International School For Excellence, Khuian Sarwar has composition of School Management Committee as per laws.

### Functions of School Management Committee

The School Management Committee shall perform the following functions namely:

- 1) Ensure the regularity and punctuality in attendance by teachers of the school.
- 2) Assess the learning ability of each child and accordingly supplement additional instructions if any required.
- 3) Bring to the notice of the Local Education Authority any deviation from the rights of the child, in particular mental and physical 4 harassment of the children, denial of admission and timely provision of free entitlements.
- 4) Communicate in simple and creative ways to the population in the neighbourhood of the school, the rights of the child as enunciated in the Act as also the duties of the appropriate government, local authority, school, parents and guardian.

- 5) Ensure that no child shall be liable to pay any kind of fee or charges or expenses which may prevent him or her from pursuing and completing the elementary education.
- 6) Identify the needs, prepare a plan, and monitor the implementation of the provisions, where a child above six years of age has not been admitted in any school or though admitted, could not complete his or her Elementary Education, then, he or she shall be admitted in a class appropriate to his or her age.
- 7) School Management Committee constituted under subsection (1) of section 21 shall prepare a School Development Plan every year in such manner as may be prescribed.
- 8) The School Management Committee shall prepare a School Development Plan at least three months before the end of the financial year in which it is first constituted under Act.
- 9) Monitor that teachers are not burdened with non-academic duties other than those specified in section 27. No teacher shall be deployed for any non-educational purposes other than the decennial population census, disaster relief duties or duties relating in elections to the local authority or the state legislatures or parliament, as the case may
- 10) Prepare an annual account of receipts and expenditure of the school. Any money received by the said committee for the discharge of its functions under this Act, shall be kept in a separate account to be audited annually.
